"The quotation made by the VC is half-baked as the UGC Model CRR clearly stated that appointment should be done only by the Selection Committee after advertisement for the same has been published in the newspaper," Kma said.

Stating that even the President of India has to follow procedures, he asked if the VC is above the President.


"We condemn this act and statement of the VC where he claimed that he has followed the rules," he said.
