

Centre promises to add Garo in tentative list of languages

SHILLONG, Nov 3: The Ministry of Home Affairs (MHA) has granted the request of the state for inclusion of the Garo language to the preliminary list of Indian languages that are awaiting recognition under the Eighth Schedule of the Constitution.

The Khasi language is mentioned on the list of 38 languages that were being considered for potential inclusion. There was no mention of the Garo language, earlier.

Lok Sabha member from Tura, Apatha K Sangma led a state delegation to meet with Union Home Secretary, Ajay Kumar Bhalla, to seek the inclusion of the Garo language in the provisional list.

The MHA has finally consented to add the Garo language on the list per their request, Chief Minister Conrad K Sangma announced on social media

on Friday.

Prior to the Centre's nod, the delegation, led by the Tura MP and consisting of Assembly Speaker Thomas A Sangma, Cabinet Minister Marcuse N Marak, and President of the A'chik Literature Society (Garo), Caroline R Marak, held a meeting with the MHA Secretary in Delhi and discussed the long-standing matter of adding the Garo language to the Eighth Schedule of the Indian Constitution.

"We had a fruitful discussion regarding the inclusion of the Garo Language in the list of demands for recognition under the Eighth Schedule of the Constitution," the Speaker said in a statement following the meeting, underscoring the importance of their conversation with the Home Secretary and other officials at North Block.

The Speaker stated that representatives from the Ministry of Home Affairs (MHA) were informed of the situation

and gave the delegation the assurance that the Garo languages will be added to the list of requests.

"There has been a public demand to include the Garo language in the Eighth Schedule. The MHA officials have agreed to include Garo in the official waitlist of languages based on the request of the delegation, this paves the way for Eighth Schedule inclusion," Agalho said.

Notably, the Meghalaya Legislative Assembly had approved a resolution in September 2018 to plead with the central government to add the Khasi and Garo languages to the Eighth Schedule.

Five districts of Meghalaya and some areas of the Khasi-Jaintia Hills, having a sizable Garo population, are home to speakers of the Garo language.

Presently, the Eighth Schedule of the Indian Constitution recognises twenty-two languages.

Power dept seeks ban on heavy trucks on Umiam bridge

SHILLONG, Nov 3: The Power Department has requested the Transport Department to ban overloaded trucks from plying on the bridge that spans the Umiam concrete dam's spillway.

Josephine Nongbet, the Under Secretary of the Power Department, wrote a letter to the Commissioner and Secretary of the Transport department stating that the safety audit report of the spillway, which was obtained from the Indian Institute of Technology, Guwahati, is self-explanatory.

She stated that the IIT-G's recommendations state that the bridge's maximum allowable weight is 15 MT and that "heavy-loaded vehicles should not be permitted until retrofitting of distressed members (i.e., girder beam and deck slab)".

"In light of this, we ask that you amend your department's standing order, which currently limits the gross weight of heavy-laden vehicles exceeding 20 MT to 15 MT. Please give this top consideration," she said.

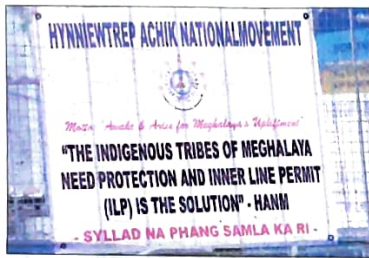
HANM protests in Delhi for ILP, language recognition

SHILLONG/MAWKYRWAT, Nov 3: The demand for the inclusion of Khasi and Garo languages in the Eighth Schedule of the Constitution, the implementation of the inner-line permit, and the Centre's intervention in resolving the interstate boundary issue echoed in New Delhi as members of the Hynniewtrep Achik National Movement (HANM) organised a sit-in at Jantar Mantar on Friday.

Led by HANM president Lamphrang Kharbani, leaders from the district councils and other citizens participated in the demonstration.

Speaking to reporters in the national capital, Kharbani criticised the Ministry of Home Affairs for not taking seriously the resolution passed by the Meghalaya

Legislative Assembly on the inclusion of Khasi and Garo languages in the Eighth Schedule and the implementation of the ILP.

He said despite the signing of an MoU for six of the 12 areas of dispute along Assam-Meghalaya border, villagers in the affected areas continue to be harassed, necessitating the Centre's intervention.

He said HANM members would return New Delhi to stage protests if the Centre continues to ignore the demands. (Contd on P-4)

Use VC's salary to pay 'illegal appointee', JAC tells NEHU

SHILLONG, Nov 3: The Joint Action Committee (JAC), which is made up of the NEHUTA, NEHUNSA, and NEHUSU, has adopted a resolution declaring that Vice Chancellor Prabha Shankar Shukla's salary will be used to cover the salaries paid to Rohit Prasad, the illegally appointed technical officer/senior consultant, with no money taken from the NEHU account.

The resolution was adopted during the second general assembly meeting of the JAC held outside the VC's office on Friday.

JAC chairman Lakshon Kma addressed the members and declared that the amount paid to Prasad as salary for the last ten months will be recovered from the VC's own remuneration.

The JAC gave a 10-day deadline to the university to comply with their demands.

Kma also insisted that the VC should make Prasad's termination letter available

to the public.

He further claimed that Shukla purposefully deleted all NEHU ordinance laws and regulations from the university's official website. As a result, there is increasing unhappiness among the faculty, support personnel, and students, he stated.

Kma warned that if their demands are not met, they will step up their agitation starting on November 13.

In the meantime, the JAC also approved a resolution requiring the VC to convene a news conference in their presence so they could refute his explanations.

Kma stated that the JAC as a whole has taken into account all of the requirements and dates that the three associations had previously established. These are now regarded as the deadlines and demands of the JAC.

Meanwhile, it was learnt that the VC will speak with the media on matters pertaining to the recent events and unrest at the Shillong Press Club on Saturday.

NPP dismisses VPP challenge in ADC polls

SHILLONG, Nov 3: The NPP announced on Friday that it will be running solo in the upcoming polls to the three autonomous district councils in the state.

The party also dismissed any threat from the VPP. "Although the VPP will be present in some constituencies, our primary opponents in the majority of the seats will be the UDP and the Congress," KHADC MDC and NPP spokesperson Bajjop Pyngrope stated on Friday.

"We recently appointed a dynamic president (Prestone Tynsong), and we will now map out our plans and hold meetings to discuss how to best position ourselves for the MDC elections," he declared.

Asked if the party will join forces with any of the political parties, he said, "We will go solo as there have not been any talks with any other political party for a pre-poll alliance or anything."

He however said, "It also depends on the party leadership but as of now there are no signs so we will go solo."

The NPP is currently leading the executive committee of all the three autonomous district councils in the state.

Fresh row over 108 service bidding

SHILLONG, Nov 3: An experience certificate issued to a Mawlat Phudmuri-based firm has become the latest bone of contention in the ongoing tussle between the bidders and the National Health Mission over the process of selecting the 108 emergency ambulance service provider for Meghalaya.

The certificate issued by NHM's mission director on September 6 states that EDNA Enterprise is involved with the state Health and Family Welfare Department through the NHM in fleet management under the Emergency Response Service on the DIAL-108 platform.

The certificate added that the vendor has a year's experience and managed at least 61 ambulances throughout the state, helping cater to more than 10,000 cases.

The bidders alleged that this certificate was given to EDNA after the tender notice was published.

Stating that EDNA was engaged in fuel-filling and was just involved in the process, the bidders said it is unbefitting of the NHM mission director to issue the certificate to the Medulance consortium.

Asking how the MD could sign the certificate after the tender was published, the bidders said the MD recorded a comment in the RFP and pre-bid that NHM is directly managing the fleet operations itself.

"Also, out of 61 vehicles mentioned in the RFP published by NHM, not all are on the road. It is quite shocking to see a certificate of experience of 61 vehicles signed," the bidders said.

When contacted, NHM Mission Director Rankumar S said that they will evaluate whatever is in their receipt and take the next steps. He admitted that the tender date was August 17 while the experience certificate was issued on September 6.

The bidders said there are videos available on social media where the workers of Medulance have alleged that the firm failed to pay the COVID warriors for their service when the country was grappling with the virus-induced lockdown.

ADC land records set to go digital

SHILLONG, Nov 3: Meghalaya's three Autonomous District Councils (ADCs) will implement a project for the digitalisation of land records in the Sixth Schedule areas.

After holding a meeting with the ADCs here on Friday, Deputy Chief Minister Prestone Tynsong told reporters the central government will fund the project through the Ministry of Land Resources.

Stating that the ADCs are being entrusted to implement the project within their respective jurisdictions, he said a project management unit will be constituted. It will be headed by the District Council Affairs department and the members will be the Deputy Commissioner (DC), District Councils etc.

The government has decided to implement the project immediately, he said, adding that it is expected to be of great benefit for the state.

According to Tynsong, registered lands with DC's office or with ADCs will be digitalised first. For unregistered lands and gift deeds, DC's office or respective District Councils will take up the responsibility.

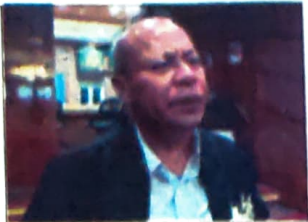
